ISSUANCE OF DEMAND LETTER TO ACCOUNTABLE OFFICAL (SCHOOL HEAD) AGAINST NON-LIQUIDATION OF CASH ADVANCE

Public Schools District Supervisors/ Principals In-Charge of the District To: Public Elementary and Secondary School Heads All Others Concerned

- 1. Pursuant to Memorandum Circular Number 23, series of 2019, particularly Section 2, which is "Legal Presumption Against Non-Liquidation of Cash Advance" cited Article 217, of the Revised Penal Code states in unequivocal terms that: "The failure of public officer to have duly forthcoming any public funds or property with which he is chargeable, upon demand by any duly authorized officer, shall be prima facie evidence that he has put such missing funds or property to personal use".
- 2. Along this vein, this office delegated the authority to the Public Schools District Supervisors (PSDSs) to send "DEMAND LETTER" to an accountable official (School Head) in his/her schools-district or municipality, demanding the liquidation/settlement of cash advances, if any.
- 3. Herewith, is the suggested format of a "Demand Letter" to be prepared and be signed by the concerned Public Schools District Supervisor for and in-behalf of the Schools Division Superintendent.
- 4. Immediate dissemination and strict compliance with this Memorandum are desired.
