#### RECONSTITUTION OF THE DIVISION FIELD TECHNICAL ASSISTANCE TEAM (DFTAT)

Assistant Schools Division Superintendent Chiefs, SGOD and CID Concerned SDO Unit/Section Heads Public School District Supervisors Elementary and Secondary School Heads All Others Concerned

- 1. In a bid to strengthen the management system for the provisions of technical assistance to the field- which is aligned with the Division Reform Agenda 3 and the PREMIER implementation mechanism, particularly on Responding to Stakeholder's needs, this office hereby reconstitutes the Division Field Technical Assistance Team (DFTAT), effective immediately.
- 2. Enclosed, please find the Reconstituted DFTAT document, for guidance of all concerned.
- 3. Essentially, all SDO-based program holders, including the public schools district supervisors are deemed Technical Assistance (TA) Providers. However, the herein-listed names of TA Providers are assigned specific areas of concern, to serve their specializations, and to establish accountability in tracking progress of TA actions and for other related purposes.
- 4. Guided by the ZAMPENTAM Handbook, the TA Providers shall, as their main duty, provide technical assistance to schools and community learning centers, to cover identified concerns, gaps and needs along the six (6) areas of school/CLC operations, so called 6 SBM Dimensions, namely: curriculum and teaching, learning environment, leadership, governance and accountability, human resource and team development, and finance & resource management and mobilization.
- 5. This Order shall remain effective unless sooner modified or otherwise revoked.
- 6. Wide dissemination of this Memorandum is desired.
