This Office reiterates the guidelines set forth by DepEd Order No. 2, s. 2015 also known as the Guidelines on the Establishment and Implementation of the Results-Based Performance Management System (RPMS) in the Department of Education and DepEd Memorandum No. 8, s. 2023 also known as Multi-Year Guidelines on the Results-Based Performance Management System-Philippine Professional Standards for Teachers.
