**PARTICIPATION TO THE REGIONAL INDIGENOUS PEOPLES SUMMIT 2024
AND FORMATION OF CONSULTATIVE AND ADVISORY BODIES (CAB)**

1. In consonance with the Regional Memorandum No. 691, s. 2024 dated October 11, 2024 on the Regional Indigenous Peoples Summit 2024 and in conformity with the 5-point agenda of the new DepEd Secretary Juan Edgardo "Sonny" Angara which is to improve the quality of education, this division announces its participation to the conduct of the said activity on October 22, 2024 at the Provincial Capitol Atrium, Ipil Heights, Ipil, Zamboanga Sibugay which will take place from 8:30am until 5:00pm.

2. With the celebration, a live-in Regional Formation of the Consultative and Advisory Bodies (CAB) will be conducted on October 21, 2024 at the Sibugay International Hotel, Ipil, Zamboanga Sibugay which will be attended by the identified elders of the seven (7) Indigenous Cultural Communities who will comprise the division CAB members. Along with the IP elders, IPED Focal and his alternate are advised to arrive at the venue on October 20, 2024 of which dinner will be served as the first meal.

3. Highlighting the IP Summit on October 22, 2024, there will be an exhibit of Teaching and Learning Resources and other materials used by the seven (7) Indigenous Cultural Communities (ICC) (Eastern, Northern, Central, Western, Tolot, Kolibugan and Sama Sibuco). The Public Schools District Supervisors' Cluster Head shall take charge of the showcasing of these materials and for the installation of the booth (5m x 3m) shall be constructed by the Tampilisan and Kalawit Districts through the Public Schools District Supervisors concerned having been nearer to the venue and expressed commitment for its installation. Further, for a district/cluster with an IP elder who passed away in 2028 to 2024 shall prepare a one-minute video presentation highlighting the invaluable contributions which impacted the IP program while in the division through the Education Program

5. In the event that the activity and/or prior activities will fall during weekends or holidays the teaching and non-teaching personnel may be granted with service credits pursuant to the guidelines on DepEd Order No. 53, s. 2023 or Compensatory Time-Off per CSC-DBM, Joint Circular No. 2, s. 2004.

6. Expenses incurred during the conduct of the activity for the PSDS, EPS, District IPED Focal, Cluster IPED Chairpersons and other personnel shall be shouldered first by them (1 night accommodation, travel expenses and per diem) prior to the reimbursement except for the lunch, am and pm snacks on October 22, 2024 which will be served by the host division. The Indigenous Peoples (IP) elders' honorarium equivalent to six hundred pesos per day and travelling expenses shall be shouldered first by the concerned district of the participating Indigenous Cultural Community. Expenses of all participants shall be charged against the 2024 IPED Program Support Funds (PSF) subject to the usual accounting and auditing rules and regulations.
