GUIDELINES IN IDENTIFYING PERSONNEL FOR TRAINING AND SCHOLARSHIP GRANTS

To: **Assistant Schools Division Superintendent Division Chiefs Education Program Supervisors/Coordinators Public Schools District Supervisors** Principals-in-charge of Districts Education Program Specialists (SEPS and EPS II) **Division Section Heads** Public Elementary and Secondary School Heads **Others Concerned** This Schools Division

- 1. DepEd-Schools Division of Zamboanga del Norte fully supports the continuous development of its manpower to improve performance scholarship/fellowship and training grants local and overseas among others. All related activities are lodged with the Human Resource Development Committee (HRDC) through the Scholarship Committee.
- 2. To ensure smooth implementation of the inclusive, gender, fair allocation of scholarship/fellowship slots and avoid loss of scholarship slots due to delay in submission of nominees, the HRDC shall maintain scholarship/fellowship/training grantees pool from where the nominees for a specific program shall be selected on the basis of the criteria set by the sponsoring agency of DepEd.
- 3. The following guidelines shall be observed in identifying the nominees:
 - a. The Schools Division Office shall maintain its own pool of nominees in specific training areas;
 - b. Personnel who were recipient of national and regional awards shall be included in the pool; and
 - c. Nominees selected should meet the following requirements and submit documents as required:
 - i. Requirements:
 - Had been in the service for at least five years with at least Very Satisfactory performance for the last two years;
 - Has shown strong leadership potential in the office station and in the
 - Has initiated innovations in the area being recommended; Has recorded performance in the related field.

- Has no pending administrative case and is of good moral character
- ls certified to be in good health by a local government physician;
- Has the capability to disseminate or train other personnel/school teachers/administrators on an area as certified by the learning area/program supervisor and endorsed by the School Head and recommended by education program supervisor/coordinator and/or section head;
- Is computer literate; and,
- 50 years old and younger or depending on the age requirement set by the sponsoring agency or department.
- ii. Documents for submission as required by the sponsoring agency
- d. The following _ criteria shall be considered:

- 4. The nominating functional division or education program supervisor or coordinator shall certify that the trained personnel shall be utilized in enhancing office/school performance along the area where they are
- 5. The pool of nominees shall be grouped by learning area and program/project and be endorsed to the trained. Scholarship Committee or the HRDC that shall then conduct final evaluation and contact the nominee for needed documents for submission.
- 6. Grantees/Trainees shall submit a pictorial narrative report to the HRDC relative to the training/scholarship program.
