

SUBMISSION OF RAPID ASSESSMENT OF DAMAGE REPORT (RADaR) DUE TO SEVERE TROPICAL STORM (STS) "KRISTINE"

- In view of the recent impact of Typhoon Kristine and with the provisions set forth in DepEd Order No. 21, s. 2015 titled "Disaster Risk Reduction and Management Coordination and Information Management Protocol" and DepEd Order No. 37, s. 2022 "Guidelines on the Implementation of the School Disaster Risk Reduction and Management Program", which mandate the timely submission of damage reports to facilitate disaster response and rehabilitation efforts. All affected public elementary and secondary school heads are directed to submit reports on the extent of damages sustained by their respective schools through https://bit.ly/SDOZNSTSKristine.
- 2. To ensure prompt intervention responses, the link will remain open only until 9:00 AM on October 28, 2024, after which data will be consolidated, validated, and submitted to the Regional Office.
- The District Disaster Risk Reduction and Management (DRRM) Team, led by the Public Schools District Supervisors (PSDS), is tasked with overseeing and monitoring the responses from all schools within their respective districts to ensure that schools requiring assistance are accurately accounted for.
