SUBMISSION OF APPROVED SCHOOL CONTINGENCY PLANS

- Anchored on Republic Act 10121, also known as the Philippine Disaster Risk Reduction and Management Act of 2010, this memorandum reinforces the mandate to establish coordination mechanisms among government agencies, local government units, civil society organizations, and other stakeholders to enhance disaster risk reduction and management efforts. In alignment with this mandate, DepEd has issued guidelines integrating disaster risk reduction and management (DRRM) into the education sector, as stipulated in DepEd Order No. 31, s. 2015, DepEd Order No. 37, s. 2015, and DepEd Order No. 33, s. 2021.
- Following these directives, the Schools Division of Zamboanga del Norte successfully concluded a series of Contingency Planning Workshops on September 5, 2024. These workshops were conducted in six batches and involved School Heads, Public Schools District Supervisors, and selected PDOs I and AOs II, serving a total of 759 schools and 35 districts.
- In view of this, all schools are required to submit their finalized and verified Contingency Plans in scanned PDF format through the official portal www.depedzn.net no later than November 15, 2024. The plans must be complete, approved, and verified to ensure compliance with the established guidelines.
- To facilitate this process, the District DRRM Team is tasked with supervising the 4. completion and verification of the school contingency plans. The team is also responsible for endorsing and certifying the plans, which should include a signed certification and endorsement letter (Annex A: Certification). Furthermore, the District DRRM Team is expected to consolidate and submit the verified plans for all schools within their respective districts through the provided link. The District DRRM Team is composed of the Public Schools Division Supervisor, the District DRRM Coordinator, the District DRRM Co-Coordinator, and a representative School Head from the elementary or secondary level.
