**SCHOOL-BASED FEEDING PROGRAM (SBFP) IMPLEMENTATION SCHOOL
 YEAR 2024-2025**

1. As part of the Implementation timeline for FY 2024 per OUOPS-2024-09-04944 Fifth Advisory for the Implementation of the School-Based Feeding Program SY 2024-2025, SBFP will be simultaneously implemented in recipient schools to be identified for 160 days starting August 19, 2024 to include holidays.
2. Recipient for the SBFP SY 2024-2025 will undergo anthropometric assessment of all learners Kinder to Grade 6 from July 29, 2024 to August 2, 2024. Submission of report shall not be later than August 9, 2024 to give time for SDO Consolidation and Mapping.
3. Moreover, the SBFP for National Learning Camp (NLC) will follow after the 160-day implementation to cover all enrolled campers for fifteen (15) days.
4. In view of the foregoing, there will be a virtual pre-implementation meeting with the supplier and the District Inspectorate Team (DIT) on August 15, 2024 at 9:00 AM-12:00NN. Link will be provided later on.
5. Within 2 weeks after the end of implementation, all schools shall submit the Program Terminal Report (PTR) for SY 2024-2025.
