WHEREAS, on October 12, 2023 @ **3:00 p.m.**, the BAC conducted an on-site Pre-Procurement Conference for the procurement project *Early Procurement Activity (EPA) for the Board and Lodging for CID Learning and Development Activities for 2024-Developmentally Appropriate Teaching-Learning Approaches to Address Critical Content Across Grade Levels and Learning Areas (LOT 1), Training on effective Coaching and Mentoring Program for Master Teachers (Lot 2), and Training Workshop on the Development of ZN Portable Academic Device (PAD) for Kindergarten to Grade 10 (Lot 3)*;

WHEREAS, the DepEd, Division of Zamboanga del Norte, Estaka, Dipolog City advertised the Invitation to Apply for Eligibility and to Bid for *Early Procurement Activity (EPA) for the Board and Lodging for CID Learning and Development Activities for 2024 with three (3) lots*, published in PHILGEPS and posted within the premises of the Schools Division Office of the Schools Division of Zamboanga del Norte continuously from **October 28, 2023** up to the scheduled opening of Bids on **November 20, 2023**;

WHEREAS, on **November 6, 2023 @ 3:00 p.m.** the BAC conducted an on-site and online **Pre-Bid Conference** with the presence of three (2) interested bidders;


