WHEREAS, on **October 15, 2020 @ 3:00 PM**, the BAC conducted a virtual **Pre-Procurement Conference** for the impending procurement project Printing and Delivery of Self-Learning Modules for Quarter 2, SY 2020-2021 thru google.meet;

WHEREAS, the DepEd, Division of Zamboanga del Norte, Estaka, Dipolog City advertised the Invitation to Apply for Eligibility and to Bid for the **Printing and Delivery of Self-Learning Modules(SLMs), for Quarter 2, SY 2020-2021- Lots 1,2, 3 & 4** , published in PHILGEPS and posted in the conspicuous places such as at the premises of the DepEd, Divisions of Zamboanga del Norte continuously from **October 15, 2020** up to the scheduled opening of Bids dated **November 5, 2020**;

WHEREAS, on **October 23, 2020 @ 3:00 PM** the BAC conducted a virtual **Pre-bid Conference** with the virtual presence of five (5) interested bidders thru google.meet.

WHEREAS, in response to the said advertisements, eight (8) prospective bidders requested the data (DRL) through the PhilGEPS website, but eventually there was only one (1) bidder who submitted its letter of intent to participate in the bidding and, went on to purchase the bid documents for each of the four(4) lot projects ;

WHEREAS, said bidder timely submitted its proposals, and on **November 5, 2020**, the **bid opening** was conducted, which reveals;
