CONTRACT AGREEMENT

THIS AGREEMENT, made this 21st day of June, 2024 between DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and MIBANG HOTEL, Sta. Felomina, Dipolog City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier executes the "Board and Lodging for the Conduct of Phase 1 Project C.A.D.R.E. (Capacity Building and Disaster Readiness in Education)" (hereinafter called "The Project") with Contract No. CB-2024-027 and the Entity has accepted the bid for One Million Six Hundred Sixty Seven Thousand Five Hundred Pesos Only (Php1,667,500.00) by the Supplier for the execution and completion of such Project within the training schedules fixed by the program proponent, and the remedying of any defects therein.

 - (k) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Project and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Project and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
