



THIS AGREEMENT, made this 14<sup>th</sup> day of December 2022 between DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and AB CATAMCO MARKETING AND ENTERPRISE, Cinco St., Brgy.
