

CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 05 2022, 2022 between **DepEd- SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE**, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and **MJMARI BUILDERS AND DEVELOPMENT CORPORATION**, 088 Purok Gemelina, National Highway, Sanito, Ipil, Zamboanga Sibugay (hereinafter called the "Contractor").




