
CONTRACT AGREEMENT

THIS AGREEMENT, made this \(\frac{1240}{240}\) day of May, 2024 between DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and YSL BUILDER, Gen. Luna St., Dipolog City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor executes the "Early Procurement Activity (EPA) for the Proposed Construction of 2 Units One (1) Storey - Two (2) Classrooms School Building (with common toilet) with Provision of Rainwater Collector, School Furniture, Perimeter Solar Light, Solar PV Energy System and Water System at Tinago ES, Sergio Osmeña-Lot 1" (hereinafter called "The Project") with Contract No. CB-2024-018 and the Entity has accepted the bid for Twenty-Five Million Six Hundred Ninety-Eight Thousand Four Hundred Ninety-Seven Pesos & 43/100 (P 25,698,497.43) by the Contractor for the execution and completion of such Project, within one hundred eighty (180) calendar days from the date of receipt of the Notice to Proceed, and the remedying of any defects therein.

 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.

In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Project and remedy any defects therein in conformity with the provisions of this Contract in all respects.
