WHEREAS, the DepEd, Division of Zamboanga del Norte, Estaka, Dipolog City advertised the Invitation to Apply for Eligibility and to Bid for *Proposed Construction of One (1) Storey - School Clinic (Health Facility) @ Liloy NHS*, published in PHILGEPS and posted within the premises of the Schools Division Office of the Schools Division of Zamboanga del Norte continuously from **November 16, 2023** up to the scheduled opening of Bids on **December 7, 2023**;

WHEREAS, on **November 24, 2023 @ 3:00 p.m.** the BAC conducted an on-site and online **Pre-Bid Conference** with the presence of fifty-five (55) interested bidders;




