WHEREAS, on **November 29, 2023 @ 1:30 p.m.**, the BAC conducted an on-site Pre-Procurement Conference for the procurement project *2024 Early Procurement Activity (EPA) for the Construction of One (1) Storey School Clinic at Piñan National High School Under Basic Education Facilities Fund*;

WHEREAS, the DepEd, Division of Zamboanga del Norte, Estaka, Dipolog City advertised the Invitation to Apply for Eligibility and to Bid for *2024 Early Procurement Activity (EPA) for the Construction of One (1) Storey School Clinic at Piñan National High School Under Basic Education Facilities Fund*, published in PHILGEPS and posted within the premises of the Schools Division Office of the Schools Division of Zamboanga del Norte continuously from **November 30, 2023** up to the scheduled opening of Bids on **December 26, 2023**;

WHEREAS, on **December 11, 2023 @ 10:00 a.m.** the BAC conducted an on-site and online **Pre-Bid Conference** with the presence of fifteen (15) interested bidders;

WHEREAS, in response to the said advertisements, two (2) prospective bidders submitted its intent to participate in the bidding and, went on to purchase the bid documents for the project;

WHEREAS, one (1) prospective bidder timely submitted its proposal, and on **December 27, 2023**, the **bid opening** was conducted, which reveals;
