CONTRACT AGREEMENT

THIS AGREEMENT, made this 19th day of April, 2024 between DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and ANDSONS EDUCATIONAL RESOURCES, INC., Block 22, Sicily Street Pallas Athena Executive Village Anabu II-C, Imus City, Cavite (hereinafter called the "Supplier").
