**CONTRACT AGREEMENT**

THIS AGREEMENT, made this 4<sup>th</sup> day of June, 2024 between **DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE**, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and **MIL TOWERS CONSTRUCTION**, Purok Jupiter, Bangkerohan, Ipil, Zamboanga Sibugay (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor executes the "**Construction of Five (5) Temporary Learning Spaces at Baybay Central School**" (hereinafter called "The Project") with **Contract No. CB-2024-024** and the Entity has accepted the bid for **Eight Hundred Seventy-Two Thousand Nine Hundred Fifty-One Pesos & 50/100 (P 872,951.50)** by the Contractor for the execution and completion of such Project, **within sixty (60) calendar days** from the **date of receipt of the Notice to Proceed**, and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Project and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Project and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.




