THIS AGREEMENT, made this \_\_\_\_\_ day of July, 2024 between DepEd- SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and YSL BUILDER, Gen. Luna St., Dipolog City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor executes the "Conservation and Restoration of Gabaldon School Buildings-Lapayanbaja ES-Lot 1" (hereinafter called "The Project") with Contract No. CB-2024-036 and the Entity has accepted the bid for Twenty-Two Million Nine Hundred Ninety-Nine Thousand Six Hundred Twenty-Seven Pesos & 62/100 (Php 22,999,627.62) by the Contractor for the execution and completion of such Project, within two hundred ten (210) calendar days from the date of receipt of the Notice to Proceed, and the remedying of any defects therein.


#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Project and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Project and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
