

CONTRACT AGREEMENT

THIS AGREEMENT, made this 09 SEP 2024 day of _____, **2024** between **DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE**, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and **YSL BUILDER**, Gen. Luna St., Dipolog City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor executes the "**Construction of 2-Storey 6-Classrooms Under 2024 QRF**" (hereinafter called "The Project") with **Contract No. CB-2024-043** and the Entity has accepted the bid for **Twenty-Four Million Eight Hundred Thirty-Seven Thousand Nine Hundred Forty-Two Pesos & 65/100 (P 24,837,942.65)** by the Contractor for the execution and completion of such Project, **within two hundred forty (240) calendar days** from the **date of receipt of the Notice to Proceed**, and the remedying of any defects therein.

 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Project and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Project and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
