CONTRACT AGREEMENT

THIS AGREEMENT, made this JULY 23 day of 2022, 2022 between **DepEd- SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE**, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and **JOHANN'S GENERAL MERCHANDISE**, Poblacion III, Clarin, Misamis Occidental (hereinafter called the "Supplier").

 - (k) Other contract documents that may be required by existing laws and/or the Entity.
