

CONTRACT AGREEMENT

THIS AGREEMENT, made this 3rd day of October, 2022 between **DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE**, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and **AICEE CATERING FOOD SERVICES**, Caloocan City, Metro Manila (hereinafter called the "Supplier").


