THIS AGREEMENT, made this 9th day of December, 2022 between DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and LOVELY BAZAR, Rizal Avenue, Dipolog City (hereinafter called the "Supplier").

 - (k) Other contract documents that may be required by existing laws and/or the Entity.
