WHEREAS, on May 23, 2022 @ 3:00 P.M., the BAC conducted an on-site Pre-Procurement Conference for the procurement project Supply and Delivery of Fruits for School-Based Feeding Program (SBFP)- Nutritious Food Product Component Implementation, S.Y. 2021-2022;

WHEREAS, the DepEd, Division of Zamboanga del Norte, Estaka, Dipolog City advertised the Invitation to Apply for Eligibility and to Bid for the **Supply and Delivery of Fruits for School-Based Feeding Program (SBFP)-Nutritious Food Product Component Implementation**, published in PHILGEPS and posted within the premises of the Schools Division Office of the Schools Division of Zamboanga del Norte continuously from **May 24, 2022** up to the scheduled opening of Bids on **June 14, 2022**;

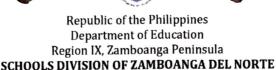

### CONTRACT AGREEMENT
