**RE-BIDDING OF PROCUREMENT OF TWO (2) UNITS SERVICE VEHICLES**

1. The Schools Division of Zamboanga del Norte, through **Special Allotment Release Order (SARO)- ROIX-22-0008007**, intends to apply the sum of **Three Million, Seven Hundred Seventy Thousand Pesos & 00/100, Philippine Currency, (Php 3,770,000.00)** being the ABC to payments under the contract for **Re-Bidding of Procurement of Two (2) Units Service Vehicles** with project Identification Nos.: **2022-43CBZN and 2022-44CBZN** for the following lots, respectively:

Bids received in excess of the ABC of the project for each lot shall be automatically rejected at bid opening.

2. The Schools Division of Zamboanga Del Norte, through the Bids and Awards Committee, now invites bids for the above procurement project. The Delivery of the Goods is required to be completed within fifteen calendar (15) days from the receipt of Notice of Order. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

7. Bids in three (3) copies including the original must be duly received by the BAC Secretariat through manual submission at the office address indicated below before or at exactly 11:00 AM of November 29, 2022. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on November 29, 2022 at 2:00 PM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

This Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
