**RECONSTRUCTION OF CLASSROOMS IN SIPALOC

1. The *Schools Division of Zamboanga del Norte*, through **2021 Quick Response Fund** intends to apply the sum of **Four Million, Five Hundred Fifty-Three Thousand, Four Hundred Sixty-Three Pesos & 46/100, Philippine Currency, (PhP 4,553,463.46)** being the ABC to payments under the contracts for *Reconstruction of Classrooms in Sipaloc Elementary School Under 2021 Quick Response Fund with contract Identification No. 2021-022CBZN*, for the project;

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *Schools Division of Zamboanga Del Norte* now invites bids for the above lot procurement projects. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *the Schools Division of Zamboanga Del Norte* and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 P.M.
5. A complete set of electronic/soft copy of Bidding Documents may be acquired by interested Bidders from **June 1, 2021 to June 22, 2021**, in the given address and website below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB*, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (P5,000.00)** only for project with an ABC of above One Million up to 5M..
6. The *Schools Division of Zamboanga Del Norte* will hold a virtual Pre-Bid Conference<sup>1</sup> on **June 9, 2021 at 3:00 P.M.** via google meet with the link (<https://meet.google.com/hhn-vezc-rnw>) which shall be open to prospective bidders.
7. Bids in four (4) copies including the original must be duly received by the BAC Secretariat through manual submission at the office address indicated below **on or before 1:00 PM of June 22, 2021**. Late bids shall not be accepted.
