INVITATION TO BID CONSTRUCTION OF HANDWASHING FACILITIES IN VARIOUS SCHOOLS OF ZAMBOANGA DEL NORTE DIVISION UNDER CY 2022 BEFF

1. The Schools Division of Zamboanga del Norte, through CY 2022 Basic Education Facilities Fund intends to apply the sum of Three Million, Two Hundred Ninety-Three Thousand, Six Hundred Eighty-Four Pesos & 80/100, Philippine Currency, (PhP 3,293,684.80) being the ABC to payment under the contract for Construction of Handwashing Facilities in Various Schools of Zamboanga del Norte Division Under CY 2022 BEFF with contract Identification Nos. 2022-004CBZN and 2022-005CBZN, for the following lots;

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The Schools Division of Zamboanga Del Norte now invites bids for the above lot procurement project. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Biding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from the Schools Division of Zamboanga Del Norte and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 P.M.
- 5. A complete set of electronic/soft copy of Bidding Documents may be acquired by interested Bidders from April 5 to April 26, 2022, in the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos for each lot (P5,000.00).
- 6. The Schools Division of Zamboanga Del Norte will hold a virtual Pre-Bid Conference on April 13, 2022 at 10:00 A.M. via google meet with the link (https://meet.google.com/rws-vmgb-pfs) which shall be open to prospective bidders.
