The Schools Division of Zamboanga del Norte, through OSEC-9-ZN-21-1856 intends to apply the sum of Six Million, One Hundred Thirty-Six Thousand Pesos & 00/100, Philippine Currency, (PhP 6,136,000.00) being the ABC to payment under the contract for Supply and Delivery of Information Technology Devices for Learning Support, S.Y. 2021-2022 with contract Identification Nos. 2021-040CBZN and 2021-041CBZN, for the following lots:

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The Schools Division of Zamboanga Del Norte now invites bids for the above procurement project. One-time delivery of the Goods is required to be completed within twenty (20) days from receipt order/ notice to proceed for Lot 1, within fifteen (15) days from receipt order/ notice to proceed for Lot 2. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant

Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from *the Schools Division of Zamboanga Del Norte* and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 P.M.
- 5. A complete set of electronic/soft copy of Bidding Documents may be acquired by interested bidders from *November 4, 2021 to November 25, 2021*, in the given address and website below *and pursuant to the latest Guidelines issued by the GPPB*, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Four Thousand Pesos (Php 4,000.000) for Lot 1 and Two Thousand Pesos (Php 2,000.00) for Lot 2.

- 8. Bids in four (4) copies including the original must be duly received by the BAC Secretariat through manual submission at the office address indicated below **on or before 2:00 PM of** *November 25, 2021*. Late bids shall not be accepted.
- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 10. Bid opening shall be on *November 25, 2021 at 3:00 PM* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 11. This Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
