The Schools Division of Zamboanga del Norte, through **CY 2023 LAST MILE SCHOOLS PROGRAM**, intends to apply the sum of Seventeen Million One Hundred Sixty-Six Thousand Eight Hundred Ninety-Five Pesos & 91/100, (P17,166,895.91) being the ABC to payments under the contract for **Construction of One Storey- Two Classrooms School Building (with common toilet) with provision of rainwater collector, School Furniture, Perimeter Solar Light and Solar PV Energy System** with Project Identification No. **2023-008-CBZN**, for the project;

Bids received in excess of the ABC for the project shall be automatically rejected at bid opening.

2. The Schools Division of Zamboanga Del Norte, through the Bids and Awards Committee, now invites bids for the above lot procurement project. Completion of the Works is required within **90 days**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

A complete set of electronic/soft copy of Bidding Documents may be acquired by interested bidders from April 6, 2023 to April 27, 2023, in the given address and website below and pursuant to the latest guidelines issued by the GPPB, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Twenty-Five Thousand Pesos (P25,000.00) for each lot. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through electronic means before or upon dropping of proposal.
6. The Schools Division of Zamboanga Del Norte will hold a Face-to-Face Pre-Bid Conference on April 14, 2023 at 3:00 P.M. at the 4th Floor, New SDO Building, Estaca, Dipolog City, which shall be open to prospective bidders.
7. Bids in three (3) copies including the original must be duly received by the BAC Secretariat through manual submission at the office address indicated below before or at exactly 11:00 AM of April 27, 2023. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on April 27, 2023 at 3:00 PM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

This Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
