The Schools Division of Zamboanga del Norte, through CY 2023 BEFF, intends to apply the sum of Five Million Nine Hundred Ninety Thousand Three Hundred Fifty-Six & 98/100, (P5,990,356.98) being the ABC to payments under the contract for Electrification of Un-Energized Schools and Modernization of Electrical Systems on-grid Schools CY 2023 Basic Educational Facilities Fund with Project Identification Nos. 2023-005-CBZN and 2023-006CBZN, for the following lots, respectively;

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The Schools Division of Zamboanga Del Norte, through the Bids and Awards Committee, now invites bids for the above lot procurement project. Completion of the Works is required within 90 days. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Biding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on April 27, 2023 at 3:00 PM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
