The Schools Division of Zamboanga del Norte, through **CY 2022 QUICK RESPONSE FUND**, intends to apply the sum of One Million Nine Hundred Ninety-Eight Thousand One Hundred Ninety-Six Pesos & 19/100, (P1,998,196.19) being the ABC to payments under the contract for **Repair and Rehabilitation of Two (2) Classrooms Under the CY 2022 Quick Response Fund** with Project Identification No. **2023-022-CBZN**, for the project;

Bids received in excess of the ABC for the project shall be automatically rejected at bid opening.

2. The Schools Division of Zamboanga Del Norte, through the Bids and Awards Committee, now invites bids for the above procurement project. Completion of the Works is required to be **completed within the given schedule**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the Schools Division Office of Zamboanga Del Norte and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.
