INVITATION TO BID

CONSTRUCTION OF ONE (1)-STOREY, TWO (2)-CLASSROOM SCHOOL BUILDING WITH ANCILLARY STRUCTURE AND PROVISIONS OF RAINWATER COLLECTOR, SCHOOL FURNITURE, SOLAR PV ENERGY AND WATER SYSTEM AT HEAD TIPAN ELEMENTARY SCHOOL – MUTIA DISTRICT

1. The Schools Division of Zamboanga del Norte, through **CY 2022 Basic Educational Facilities Funds** intends to apply the sum of **Fifteen Million Nine Hundred Sixteen Thousand Nine Hundred Twenty-One Pesos & 53/100, Philippine Currency, (PhP 15,916,921.53)** being the ABC to payment under the contract for **Construction of One (1)- Storey, Two (2)- Classrooms School Building with Ancillary Structure and Provisions of Rainwater Collector, School Furniture, Solar PV Energy and Water System at Head Tipan Elementary School – Mutia District** with contract Identification No. **2022-055CBZN**, for the project;

Bids received in excess of the ABC for the project shall be automatically rejected at bid opening.

2. The Schools Division of Zamboanga Del Norte, through the Bids and Awards Committee, now invites bids for the above lot procurement project. **Completion of the Works is required within one hundred twenty (120) calendar days.** Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *the Schools Division of Zamboanga Del Norte* and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 P.M.

A complete set of electronic/soft copy of Bidding Documents may be acquired by interested Bidders from **October 28, 2022 to November 18, 2022**, in the given address and website below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB*, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Twenty-Five Thousand Pesos (Php 25,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through electronic means before or upon dropping of proposal.
6. The Schools Division of Zamboanga Del Norte will hold an on-site Pre-Bid Conference on **November 7, 2022 at 1:00 P.M.** at 4th Floor Conference Hall, New SDO Building, Estaka, Dipolog City, which shall be open to prospective bidders.
7. Bids in three (3) number of copies including the original must be duly received by the BAC Secretariat through manual submission at the office address indicated below **on or before 11:00 AM of November 18, 2022**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **November 18, 2022 at 3:00 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

This Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
