## **INVITATION TO BID**

## Supply and Delivery of ICT Items for the BE-LCP AND ADM Implementation SY 2020-2021

1. The Schools Division of Zamboanga del Norte, through SARO-ROIX-ZN-20-11-720 intends to apply the sum of Twelve Million, Eight Hundred Forty-Two Thousand, One Hundred Pesos, Philippine Currency, (PhP 12,842,100.00) being the ABC to payment under the contract for Supply and Delivery of ICT Items for BE-LCP& ADM Implementation SY 2020-2021 with contract Identification Nos. 2021-0010CBZN, for the project;

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The Schools Division of Zamboanga Del Norte now invites bids for the above procurement project. One-time delivery of the Goods is required to be completed within thirty (30) days from receipt order. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from *the Schools Division of Zamboanga Del Norte* and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 P.M.
- 5. A complete set of electronic/soft copy of Bidding Documentsmay be acquired by interested Bidders from May 6, 2021 to May 27, 2021, in the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 25,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through electronic means before or upon dropping of proposal.

- 7. Bids in four (4) copies including the original must be duly received by the BAC Secretariat through manual submission at the office address indicated below **on or** *before* 2:00 PM of May 27, 2021. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *May 27, 2021 at 3:00 PM* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. This Procuring Entityreserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
