**INVITATION TO BID**

**CONSTRUCTION OF 2 UNITS, 1-STOREY, 2-CLASSROOM SCHOOL BUILDING WITH ANCILLARY STRUCTURE AND PROVISIONS AT SITOG NATIONAL HIGH SCHOOL- DABIAK EXTENSION UNDER CY 2020 LMS PROGRAM**

1. The Schools Division of Zamboanga del Norte, through **CY 2020 LMS Program** intends to apply the sum of **Twenty Million, Six Hundred Eighty-Six Thousand, Six Hundred Forty-Three Pesos & 26/100, Philippine Currency, (Php 20,686,643.26)** being the ABC to payments under the contract for **Construction of 2 Units, 1-Storey, 2-Classroom School Building with Ancillary Structure and Provisions at Sitog National High School-Dabiak Extension Under CY 2020 LMS Program with contract Identification No. 2021-023CBZN**, for the project;

Bids received in excess of the ABC for the project shall be automatically rejected at bid opening.

2. The Schools Division of Zamboanga Del Norte now invites bids for the above procurement project. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *the Schools Division of Zamboanga Del Norte* and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 P.M.**
5. A complete set of electronic/soft copy of Bidding Documents may be acquired by interested Bidders from **July 1, 2021 to July 21, 2021**, in the given address and website below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB*, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Twenty-Five Thousand Pesos (P25,000.00)**.
6. The Schools Division of Zamboanga Del Norte will hold a virtual Pre-Bid Conference<sup>1</sup> on **July 9, 2021 at 3:00 P.M.** via google meet with the link (<https://meet.google.com/cvw-ddnh-oyv>) which shall be open to prospective bidders.

9. Bid opening shall be on **July 22, 2021 at 2:00 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

This Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
