INVITATION TO BID

Printing and Delivery of 3rd Quarter Self-Learning Modules (SLMs) for the First Month of Quarter 3 S.Y. 2020-2021

1. The Schools Division of Zamboanga del Norte, through SUB-ARO NO. RO-9-ZN-21-03-074 intends to apply the sum of **Two Million, Five Hundred Seventy-One Thousand, Three Hundred Ninety-Eight Pesos & 40/100, Philippine Currency, (PhP 2,571,398.40)** being the ABC to payments under the contracts for *Printing and Delivery of 3rd Quarter Self-Learning Modules (SLMs) for the First Month of Quarter 3 S.Y. 2020-2021 with contract Identification Nos. 2021-007CBZN*, for the project;

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The Schools Division of Zamboanga Del Norte now invites bids for the above lot procurement projects. One-time delivery of the Goods is required to be completed **within ten (10) days from receipt order**. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *the Schools Division of Zamboanga Del Norte* and inspect the Bidding Documents at the address given below during *8:00 AM to 5:00 P.M.*
5. A complete set of electronic/soft copy of Bidding Documents may be acquired by interested Bidders from *April 9, 2021 to April 30, 2021*, in the given address and



website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **PhP 5,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through electronic means before or upon dropping of proposal.


6. The Schools Division of Zamboanga Del Norte will hold a virtual Pre-Bid Conference¹ on **April 16, 2021 at 3:00 P.M.** via google meet with the link (***meet.google.com/wms-euac-jwy***) which shall be open to prospective bidders.
7. Bids in four (4) copies including the original must be duly received by the BAC Secretariat through manual submission at the office address indicated below **on or before 2:00 PM of April 30, 2021**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **April 30, 2021 at 3:00 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. This Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
