The Schools Division of Zamboanga del Norte, through **CY 2022 Basic Education Facilities Fund** intends to apply the sum of **Seven Hundred Six Thousand, Nine Hundred Fifty Pesos & 00/100, Philippine Currency, (PhP 706,950.00)** being the ABC to payment under the contract for the **Supply and Door-to-Door Delivery of School Furniture at Mutia Central School Under the BEFF CY 2022** with contract Identification Nos. **2022-002CBZN**, for the project;

Bids received in excess of the ABC for the project shall be automatically rejected at bid opening.

2. The Schools Division of Zamboanga Del Norte now invites bids for the above procurement project. One-time delivery of the Goods is required to be completed **within forty (45) days from receipt order/ notice to proceed**. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *the Schools Division of Zamboanga Del Norte* and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 P.M.**
5. A complete set of electronic/soft copy of Bidding Documents may be acquired by interested Bidders from **March 4, 2022 to March 25, 2022**, in the given address and website below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB*, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **One Thousand Pesos (P1,000.00)**.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **March 25, 2022 at 3:00 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

This Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
